1. Introduction

This Privacy Policy explains how WMT Prime CORP. ("Company", "we", "us", or "our") collects, uses, stores, and protects your personal data when using the CryptoStealth software suite and related services (hereinafter referred to as the "Service").

By using the Service, you agree to the collection and use of information in accordance with this Policy. If you do not agree, please do not use the Service.

2. What Data We Collect

We collect only the minimum amount of data required to access the Service via the WebMoney system.

We may process the following categories of data:

- WebMoney Identifier (WMID) and attestation level;
- Public WebMoney profile data (if available via API);
- Encrypted user content (e.g., seed phrases, notes) stored in encrypted form using user-controlled keys;
- Technical metadata: hashed identifiers, IP addresses, access logs.

We do not collect:

- Names, email addresses, phone numbers, or identity documents directly from you;
- Private keys or unencrypted seed phrases.

3. Legal Grounds for Processing

We process your personal data based on:

WMT Prime CORP.

- Your consent (upon accepting the User Agreement);
- Legitimate interests (e.g., account verification, Service maintenance);
- Compliance with Panamanian law (Law No. 81 of March 26, 2019 on Personal Data Protection).

4. How We Use the Data

We use your data solely for the following purposes:

- Authorization and authentication via WebMoney;
- Secure encryption/decryption of your content;
- Maintaining technical functionality and security of the Service;
- Compliance with applicable laws (e.g., prevention of abuse or sanctions compliance).

5. Data Retention and Storage

Personal data is retained only as long as necessary to fulfill the purposes outlined in this Policy or as required by law.

Backups of encrypted content may be stored for continuity purposes, but are inaccessible without the user's keys.

6. Data Sharing

We do not sell, rent, or disclose your personal data to third parties, except in the following cases:

- With your explicit consent;
- To WebMoney for account verification purposes;
- To comply with legal obligations (e.g., by court order or regulatory requirement).

7. Cross-Border Data Transfers

Your data may be processed or stored in countries other than your country of residence. In such cases, we ensure adequate protection through appropriate legal mechanisms (e.g., standard contractual clauses or equivalent safeguards under Panamanian law).

8. Data Subject Rights (under GDPR and Law No. 81)

You may have the following rights:

- Right to access your stored personal data;
- Right to rectify or delete your data;
- Right to object to processing;
- Right to data portability (where technically feasible);
- Right to file a complaint with a supervisory authority.

To exercise these rights, please contact us.

9. Security Measures

We apply reasonable organizational, technical, and cryptographic measures to protect your data:

- End-to-end encryption using user-controlled keys;
- Access control and API protection;
- Regular monitoring and server security.

However, you are solely responsible for safeguarding your seed phrases and keys. If lost, access recovery is not possible.

10. Children's Privacy

The Service is not intended for users under 18 years old or citizens of the Republic of Panama. We do not knowingly collect data from minors.

11. Changes to This Policy

We may periodically update this Policy. In case of material changes, you will be notified through the Service or via notification in the System.
